<b>ONLY VALID FOR</b> competition at individual events	<b>CAN BE UPGRADED</b> to FULL or ½ YEAR Licences

### SINGLE EVENT LICENCES

Applicant <b>MUST</b> have held a <b>FULL</b> Licence in the previous year	<b>CANNOT BE UPGRADED</b> during the season
<b>ONLY VALID FOR</b> the duration of a single sanctioned meeting	<b>REQUIRES</b> a <b>FULL CURRENT</b> Medical Certificate

## RENEWAL CHECKLIST

**MEDICAL EXAMINATION (FORM 22)**

- Regardless if you had a Medical last year, you will need a NEW Medical for this season.

**FORMULA FUTURE LICENCE FORM (FORM 23FF) / FORMULA FUTURE MEDICAL (FORM 22FF)**

You must have your Club Sign off that you are a current member or provide proof of membership. You will also need to include the following:

- A photocopy of the child's NSW Maritime or other State Boating Authority Boating Licence
- Proof of Formula Future Safety Swim Test.
- Forms **MUST** be signed by a parent or guardian
- The new Formula Future Licence Form requires the parent or guardian to initial each page and sign the last page.
- **Pre-September 2016 Forms WILL NOT BE ACCEPTED**

**LICENCE FORM (FORM 23 CL)**

You must also have your Club Sign off that you are a current member. You will also need to include the following:

- A photocopy of your NSW Maritime or other State Boating Authority Boating Licence
- Signatures or other documentation proving that you have raced on 2 occasions during 2016-17.  
**Failure to provide documentation will result in a Probationary Licence being issued.**
- Proof of Cockpit Immersion Testing.
- The new Licence form requires the applicant to initial each page and sign the last page.
- **Pre-September 2016 Forms WILL NOT BE ACCEPTED**

**BOAT OWNER FORM (FORM 23 BO) – This form contains ALL information pertaining to your boat (or boats) – including Formula Futures**

You must also have your Club Sign off that you are a current member or provide proof of membership. You will also need to include the following:

- A photocopy of your NSW Maritime or other State Boating Authority registration.
- Hull Identification Number (HIN)
- The new Boat Owner form requires the applicant to initial each page and sign the last page.
- **Pre-September 2016 Forms WILL NOT BE ACCEPTED**

**ALL APPLICATIONS MUST INCLUDE PAYMENT: CHEQUES or MONEY ORDERS are to be made out in favour of Australian Power Boat Association – NSW Council.**

**If posting your Application, please allow 10 working days for processing.**

### YOUR APPLICATION WILL NOT BE PROCESSED AND RETURNED IF:

- A photocopy of your NSW Maritime or other State Boating Authority Boat Licence and/or Boat Registration is not attached.
- Forms (*Medical/Licence/Boat Owner*) are **NOT COMPLETE** or **NOT SIGNED** by **YOURSELF** or **YOUR CLUB**. It is YOUR responsibility to prove you have current Club Membership – not ours!
- **No Proof that you competed on at least 2 occasions during 2016-17 season.** If there is no proof, you will be issued with a PROBATIONARY Licence. It is YOUR responsibility to get the required Licence signatures – NOT OURS!
- There is **NO** Payment attached.
- **Pre-September 2016 Forms WILL NOT BE ACCEPTED**
